OFFICE MEMORANDUM

In partial modification of earlier OM No. DA/PEN/2/87 dated 18th June - 2012, where in Fixed Medical Allowance @ Rs.200/ per month was sanctioned wef 01.04.2012 to the Arunachal Pradesh Government pensioners / family pensioners, the Governor of Arunachal Pradesh is pleased to accord sanction for **Fixed Medical Allowance @ Rs. 300/ (Rupees three hundred) per month with retrospective effect from 01.09.2008** payable to the A.P Govt pensioners / family pensioners along with the monthly pension.

However, the arrear of the Fixed Medical Allowance be paid in 2 (Two) installments as under: -

- i. For the period from 01.09.2008 to 31.03.2011 in financial year 2013-14.
- ii. For the period from 01.04.2011 to 31.03.2013 in April - 2014.

The arrear already accrued wef 01.04.2013 to till date may also be paid now.

The Pension Disbursing Authorities may release the arrears after adjusting the payments already made on this account.

Other terms and conditions envisaged in earlier OM No. DA/PEN/2/87 dated 18th June - 2012 remain unchanged.
