NOTIFICATION

The 19th September, 2024

No. HFW-11011/9/2020.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of Recruitment Rules for the post of Sister /Sister Tutor vide Notification No. MEST-78/139 dated 20th February, 1980 except as respect to things done or omitted to be done before such supersession, the Government of Arunachal Pradesh hereby makes the following rules to regulate the method of recruitment to the post(s) of Tutor Group 'A' (Gazetted), Non - Ministerial in the Department of Health & Family Welfare under the Government of Arunachal Pradesh, namely:-

- Short title and commencement :** (i) These rules may be called "The General Arunachal Service, "Tutor" Group-'A'(Non Ministerial) Gazetted Recruitment Rules, 2024".
(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
(iii) These rules shall apply to the posts as specified in Column (1) of the Schedule annexed to these rules.

Number or posts, classification and Level in Pay Matrix :- The number of the said posts, their classification and Level in the pay matrix attached thereto shall be as specified in column 2 to 4 in the schedule aforesaid.

Method of recruitment, age limit and other qualifications :- The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be specified in columns 5 to 13 of the schedule aforesaid.

4. Initial Constitution :-

- The personnel holding the post specified in Column 2 on long term basis, before the commencement of these rules, shall be deemed to have been appointed in accordance with the provisions of these rules.
- The regular continuous service personnel holding the post at the commencement of these rules shall count for the purpose of probationary period, qualifying service for promotion and pension.

Disqualification :- No person,

- who has entered into or contracted a marriage with a person having a spouse living; or
- who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post;

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- Power to relax :-** Where the State Government is of the opinion that, it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with APPSC, relax any of the provisions of these rules with respect to any class or category of persons by observing the procedures as prescribed under OM No. AR- 89/2012 dated 6th March, 2013.

7. **Repeal and Saving :-** The Recruitment Rules and Procedures corresponding to these Rules Procedures in force immediately before the commencement of these rules is hereby repealed provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to provide for the Arunachal Pradesh Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

(ii) The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Departments of the Central or State Government shall ordinarily not exceed 3 (three) years.
