The appointment shall be based on the following terms and conditions:-

1. **Nature of Engagement** :- The engagement shall be purely contractual and temporary for a period of 01 (one) year, or as specified in the engagement order.
2. **Place of Posting** :- APPSCB, Chimpu.
3. **Remuneration** :- The selected candidate shall be paid a consolidated monthly remuneration of **Rs. 15,000/-Rupees (Fifteen Thousand)** only as approved by competent authority.
4. **Duties and Responsibilities** :-
 - a) Provide physiotherapy and sports injury management for police sportspersons.
 - b) Provide pre-event, during-event and post-event physiotherapy support.
 - c) Attend sports camps, tournament and competitions whenever directed.
5. **Working Hours** :- Monday to Friday (**Normal Duty**)
 - a) Shift-1 :- Morning (6 am to 8 am)
 - b) Shift-2 :- Evening (4 pm to 6 pm)
 - c) In addition to above normal duty, the appointed physiotherapist has to attend the player whenever required during emergency.
6. **Provisions for waiting list/replacement** :- In the event that the first-rank/selected candidate declines to join, fails to join within the prescribe time, proceeds on long leave, remains unavailable for an extended period, resigns, or otherwise becomes unable to perform the duties of physiotherapist, the 2nd rank candidate in the merit/selection list may be offered the contractual engagement, subject to approval of the competent authority and fulfilment of all prescribed eligibility conditions.
Vice-versa, if the 2nd rank candidate is appointed in place of the 1st rank candidate and subsequently becomes unavailable due to long leave, resignation, non-joining or any other valid reason the next eligible candidate in the merit/waiting list may be considered for appointment.
7. **Verification** :- The engagement shall be subject to verification of educational/professional qualifications, registration, experience, identity, character/antecedents and other documents submitted by the candidate.
8. **False information** :- If any information or document submitted by the selected candidate is found false, incorrect or fabricated, the engagement may be cancelled/terminated and further action may be taken as per applicable rules.
9. **Acceptance** :- The selected candidate shall submit a written undertaking accepting all terms and conditions before/at the time of joining.
10. **Revocation** :- The contractual engagement may be terminated by the APPSCB/Competent Authority at any time in case of unsatisfactory performance, misconduct, negligence of duty, indiscipline, or violations of the terms and conditions of engagement.
11. **Leave** :- He/she can avail 10 (Ten) days of leave during period of contract with the Board.
12. **Authority's decision** :- The decision of the competent authority regarding the engagement, posting, duties and interpretation of the terms and conditions shall be final subject to applicable rules.
